Grant Guidelines

Funding available through Targeted Programs is for projects which help schools and school communities to improve the learning outcomes of students who are learning languages other than English.

The AISV LOTE program is mapped against the National Statement for Languages Education in Australian Schools which provides an overarching framework for languages activities.

Eligibility to access funding:

Only students who are eligible for Australian Government general recurrent funding may receive funding under this programme. Full fee paying overseas students (FFPOS) are not eligible for assistance.

Commitments by the School:

Schools should demonstrate a commitment to meeting the requirements of Australian Government Programs in relation to the Approved Intervention.

- Undertaking the approved activities as outlined in the Programme Design document within the timelines specified;
- Obtaining approval from AISV for any proposed changes to the approved activities;
- Participating in any evaluation project(s) relating to the funding source, as outlined by the Australian Government or by AISV, within the timelines specified;
- Providing data as required by the Australian Government or by AISV in order to meet accountability or programme requirements;
- Using grant funds together with any interest earned only for the purposes of the Approved Interventions in the calendar year as specified for the Approved Intervention(s);
- Using grant funds received in addition to resources already committed by the school for the purposes of the Approved Intervention, and specifying the extent of these committed resources;
- Meeting financial and educational accountability requirements as specified by the Australian Government and as requested by AISV;
- Paying to AISV an amount equalling any unexpended grant funds within 28 days of a request by AISV or the appropriate Australian Government Minister;
- Agreeing to the right of AISV to release grant details for schools under the Programme when reporting to the Australian Government and to the sector, providing that this data does not enable users of the information to identify individual students; and
- Agreeing to host visits from the Australian Government and/or AISV representatives as required.

Projects:

Projects are a defined investment with a start and finish. The focus of the project should be directed towards sustaining the flow of the benefits from the intervention into the future. This means that all or some of the outcomes of the project should impact on future teacher and/or student learning.

Allocation of Funding:

Schools are free to allocate this grant across approved expenditures.

It may not be used for capital purposes eg computers or televisions, and it may not be used to promote religious or political beliefs.

Accountability:

As part of their educational accountability, each school in receipt of funding will be expected to complete satisfactorily the Annual Progress Report.

As part of their financial accountability, schools will be expected to sign an agreement with AISV prior to receipt of any funding. In addition, schools will sign a financial accountability statement at the end of the year, to demonstrate that all funds have been received and used for the approved purpose.

The copyright of all materials produced with funds provided under Australian Government Targeted Programs is vested in the Australian Government. In all publications, promotional materials and activities relating to these Programmes, the school must acknowledge the financial support that it has received from the Australian Government.

Indigenous Languages Grant **Submission for Funding**

Funding is available for LOTE Indigenous Languages Grants. Funding for the grants is provided by the Australian Government through the Languages Programs.

This grant will be allocated on a submission basis to schools teaching Indigenous language/s to help strengthen and promote the quality of teaching and the learning of languages other than English. The grants will be up to a maximum of \$5,000. Only one grant will be available per school.

Schools will be expected to provide AISV with a written report evaluating the outcomes of their project by Term 4, 2010.

Examples of projects which might be considered for funding include:

- Strategies to increase participation in Indigenous language learning.
- Web-based strategies to disseminate information about effective teaching practices, materials development and classroom research.
- Strategies for Indigenous intercultural language learning.
- Strategies to address Indigenous languages learning and literacy development.
- Provision of Indigenous language learning at senior secondary level.
- Languages learning in the early years of schooling.
- Indigenous languages and vocational education.
- Use of information and communication technology in language classrooms.
- Indigenous professional learning programs.
- Implementation of VELs.

2010 Specialist Consultancy Project

Funding will be available to support a limited number of schools to work with an education consultant for up to four days on a project of their choice to improve and further develop their Languages Other Than English programs.

The program will be comprised of the following elements:

1. Consultant will meet with the LOTE Co-ordinator to be briefed on the LOTE program in the school, the curriculum etc...and if possible be introduced to the LOTE staff.
2. The consultant will meet with the school Principal, Curriculum Co-ordinator and Heads of School as required.
3. Planning session
It is requested that all of the teachers participating in the project attend a session at which there will be a discussion of issues that need to be addressed, and the planning of a school-based project with embedded professional learning according to the needs of the school and staff.
4. Professional Learning sessions
A total of up to three days professional development will be provided for the participating teachers.
5. Reporting session – It will be compulsory for two members of the project team to report on outcomes of their project during Term 4, 2010.
7. A final report with recommendations for future action will be written by the project leader working with the consultant and submitted to the school and AISV at the end of 2010.

A maximum of **twelve** schools will be selected to participate in the 2010 program.

Funding:

AISV will fund a Consultant for the entire project (up to 4 days) for each school and in addition provide a grant up to \$2000 to help offset the cost of teacher release on receipt of a completed CRT form. It is a condition of acceptance into this project that the school will release the participating teachers for required meetings with the designated consultant.
